- Attend January Board of Directors Retreat
- Attend 80% of monthly Board Meetings
 - Held on the Third Tuesday of the Month 7:30-8:35 am at the NACC office
- Board Members are expected to engage in one Board committee.
- Attend and/or support all major Signature events annually (Gala, State of the City, Golf Outing, Economic Forecast)
- Attend a minimum of one NACC event (outside of Board or committee meetings) a month
- Make 2-3 introductions per year, via email, face-to-face or direct referral for potential new Members.
- Provide, on an annual basis, a minimum of \$3,000 in support, sponsorship, table purchase, advertising or \$5,000 in-kind donation above and beyond annual Membership.
